# **Assigning Bank Account Management Authority**

- 2. The signing authority previously granted to the following individual is revoked:
  - a. Tricia Callies
  - b. The President of the Association is directed to communicate this amendment to the bank and to ensure proper enforcement of this resolution
- 3. The Registered Agent of the Association is currently:

- 4. The New Agent will be:
  - a. Carla Everhart, Advantage Idaho 664 S Rivershore Lane, Suite 152 Eagle, Idaho 83616
- 5. Transactions will require the signature of one (1) signing officer and the New Agent to withdraw, or otherwise transfer funds, from bank accounts that have been established for the benefit of the Association.
